

Roanoke gun violence significantly reduced during first half of 2024

Walton County's crime rate is significantly below the state average, with a 2020 crime rate of 1.8 per 1,000 residents, compared to the state average of 2.5. In 2019, when the county's crime rate was higher, it reported 984 index crimes in 2020, a 9% decrease from the previous year.

Roanoke's police chief Scott Booth has implemented since taking office a strategy of focusing on the hotspots for crime in the city. That's where his stratified policing model comes into play.




Saving Our Streets: An inside look at a new crime-fighting strategy for Lynchburg Police


STRATIFICATION: "SERIOUSNESS OF THE CALL"

ACCOUNTABILITY MEETING STRUCTURE










MPD View

- Stratified Policing and Problem-Oriented Policing is a force multiplier
 - By what we are doing
 - Direct and efficient responses to incidents and problems
- Accountability
 - Having the team, training, technology, tools, and time to be successful
 - Accountability builds teams
- Success is not final, failure is not fatal, the only constant is the willingness to improve



Five Building Blocks of Change: ADKAR

- **Awareness** – of need for change
- **Desire** – to make the change happen
- **Knowledge** – how to change
- **Ability** – implement new skills and behaviors
- **Reinforcement** – retain the change once it is made





2023 Robbery


- Lowest in 11 years

2023 Burglaries


- Residential burglary lowest in 11 years

Theft from Motor Vehicle Decrease -24%


- Lowest in 11 years

- Decrease of 28% from 2021







Results

 - Does not include 2024 results


Stratified Policing Map








Crime Reduction Goals: Burglary

Lessons and takeaways

- Communication is critical – receptive capacity, training, ongoing
 - Change Management
 - Explaining each person's role
 - Seeing Captains in focal areas, shows Patrol engagement, everyone working, and importance in reducing the crime/disorder



Lessons and takeaways

- Monthly Accountability meetings
 - Chance for Sgts. and Lts. to see process and present on POP projects (repeat call/address)
 - Accountability of actions taken
 - *** Did you get the time, team, training, tools and technology needed to respond and be successful?
 - Accountability of Command to support every level of agency



Lessons and takeaways

- Stratified Policing Log
 - Automation, one stop for whole agency, map centric
- Increased use of SARA-S and POP Projects for long term focal areas, repeat Calls for Service, Micro Time Hot Spots
